**\$12,000 Specified Perils Mortality**

**Insurance: \$27.00**

Horse(s) you own are insured against death or destruction caused or made necessary by specified perils described in the policy, including fire, lightning, and others. Death due to illness is not covered. The maximum limit per horse/aggregate per applicant per calendar year is \$12,000 regardless of the number or value of horses you own. Claims are settled on an Actual Cash Value basis.

**\$2,500 Emergency Life Saving Surgery**

**Endorsement: \$49.00**

This Endorsement is available only if you purchase Specified Perils Mortality Insurance described above. This extension to your Specified Perils Insurance covers emergency, life-saving surgical procedures (including colic and fracture repair) that take place under a general anesthetic. The limit per horse/procedure/aggregate per applicant per calendar year is \$2,500 regardless of the number of horses you own or the number/cost of surgeries performed. There is no deductible. A surgical procedure must take place for coverage to respond. There is no coverage for surgery related to birthing, dental, arthritic changes, bone chip removal, or conditions that were present at the time insurance was purchased.

**\$50,000 AD&D Principal Sum Top-Up:**

Tack and Horse Equipment you own (excluding rider clothing and protective equipment) is insured against all risks of loss or damage, subject to standard exclusions detailed in the policy. The limit per claim/aggregate per applicant per calendar year is \$3,500 regardless of the value of the equipment lost or damaged, and is subject to a \$500 deductible. Claims are settled on an Actual Cash Value basis. For a theft claim to be made, a police report will be required.
